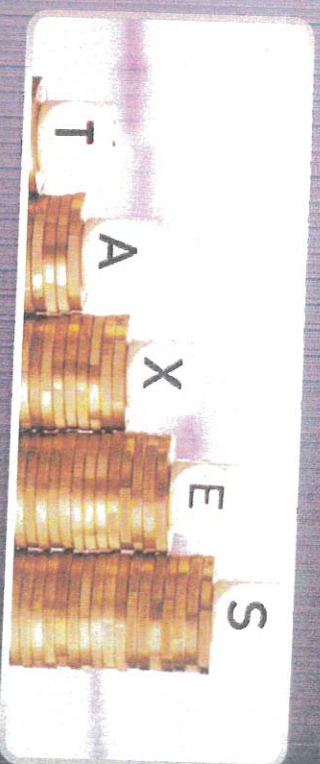




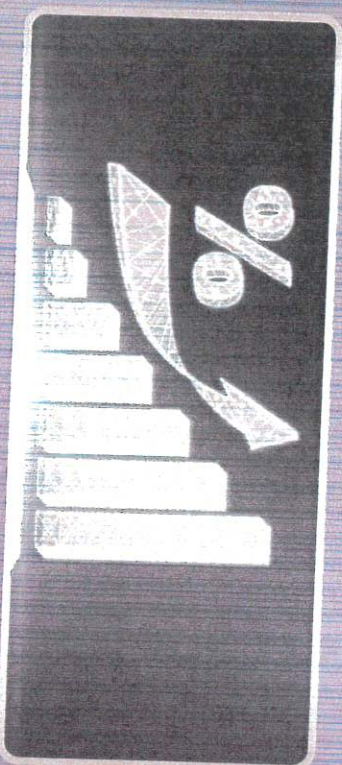
Importance

The 2026 Investment Plan will also be presented by the National Investment Commission, covering project priorities, available investment opportunities, targeted sectors, and application and implementation procedures, aimed at supporting investors' decisions and enhancing clarity in Iraq's investment landscape.



The forum also includes a specialized panel discussion for partner international organizations, ensuring direct interaction with relevant government entities and the Iraqi public sector. The session aims to clarify requirements, address challenges, and build a shared understanding that supports the business environment and enhances investor confidence.

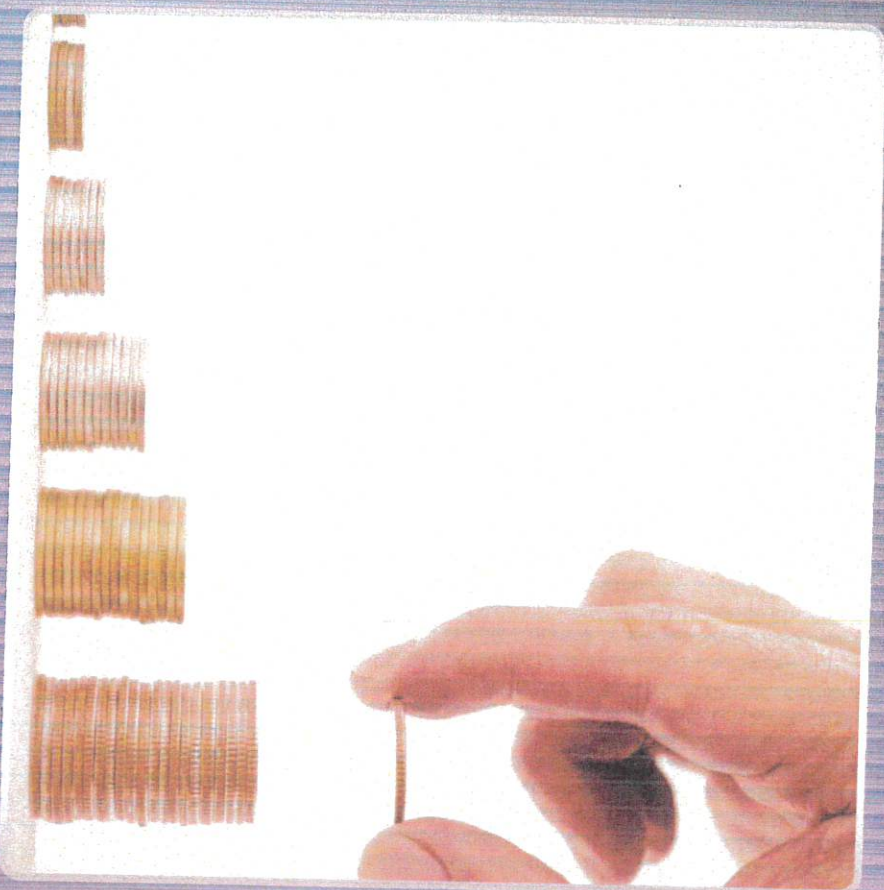
